Proposition No. 1  
(Millage Renewal)

Summary: 10 years, 7.5 mills property tax renewal for giving continuing support to the public schools of the District, in particular for salaries and benefits for all teachers and employees of the school system.

Shall School District No. 1 of the Parish of Plaquemines, State of Louisiana (the "District"), levy a special tax of seven and five tenths (7.5) mills on all property subject to taxation in the District (an estimated \$5,960,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years beginning with the year 2011 and ending with the year 2020, for the purpose of giving continuing support to the public schools of the District, in particular for salaries and benefits for all teachers and employees of the school system?

Proposition No. 2  
(Millage Renewal)

Summary: 10 years, 1 mill property tax renewal for giving continuing support to the public schools of the District, in particular for acquiring, improving and maintaining technology throughout the school system.

Shall School District No. 1 of the Parish of Plaquemines, State of Louisiana (the "District"), levy a special tax of one (1) mill on all property subject to taxation in the District (an estimated \$794,700 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years beginning with the year 2011 and ending with the year 2020, for the purpose of giving continuing support to the public schools of the District, in particular for acquiring, improving and maintaining technology throughout the school system?

Proposition No. 3  
(Millage Renewal)

Summary: 10 years, 1 mill property tax renewal for giving continuing support to the public schools of the District, in particular for acquiring, constructing, improving, maintaining and operating capital improvements throughout the school system including air conditioning.

Shall School District No. 1 of the Parish of Plaquemines, State of Louisiana (the "District"), levy a special tax of one (1) mill on all property subject to taxation in the District (an estimated \$794,700 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years beginning with the year 2011 and ending with the year 2020, for the purpose of giving continuing support to the public schools of the District, in particular for acquiring, constructing, improving, maintaining and operating capital improvements throughout the school system including air conditioning?

Proposition No. 4  
(Millage Renewal)

Summary: 10 year, 1.7 mills property tax renewal for giving continuing support to the public schools of the District, for the payment of health benefits for teachers and employees of the school system.

Shall School District No. 1 of the Parish of Plaquemines, State of Louisiana, levy a special tax of one and seven tenths (1.7) mills on all the property subject to taxation in said School District (an estimated \$1,350,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning with the year 2013 and ending with the year 2022, for the purpose of giving continuing support to the public schools of the District, for the payment of health benefits for teachers and employees of the school system?

Proposition No. 5  
(Millage Renewal)

Summary: 10 year, 2.4 mills property tax renewal for providing funds for the payment of salaries of teachers and all other employees of said School District.

Shall School District No. 1 of the Parish of Plaquemines, State of Louisiana, continue to levy a special tax of two and four tenths (2.4) mills on all of the property subject to taxation in said School District (an estimated \$1,907,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning with the year 2014 and ending with the year 2023 for the purpose of providing funds for the payment of salaries of teachers and all other employees of said School District?

Proposition No. 6  
(Millage Renewal)

Summary: 10 year, 4.78 mills property tax renewal for maintaining and operating schools and school related facilities in said School District.

Shall School District No. 1 of the Parish of Plaquemines, State of Louisiana, continue to levy a special tax of four and seventy-eight hundredths (4.78) mills on all the property subject to taxation in said School District (an estimated \$3,798,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning with the year 2014 and ending with the year 2023 for the purpose of maintaining and operating schools and school related facilities in said School District?
